

**PRE-EVENT CONSULTATION:** The parties agree to a pre-event consultation in person preferably or by phone two to three weeks before the event date in order to finalize the actual shooting times, locations, and CLIENT'S request list (in writing) for specific photographs. Unless otherwise arranged, the bride and or groom agree to set aside at least one hour of time that ends 1/2 an hour before the ceremony

commencement of the wedding and a 30-minute time frame afterward for photographs that cannot be obtained during the wedding. If the bride's or groom's late arrival prevents a full hour from occurring the photographer shall not be held liable for failure to take desired photographs.

COOPERATION: The parties agree to cheerful cooperation and communication for the best possible result within the definition of this assignment. Beth E ggert Photography recommends that CLIE NT designate an "event guide" to point out important individuals for informal or candid photographs to the photographer during the wedding that they wish to have photographed. The photographer will not be held accountable for not photographing desired people or moments if there is no one to assist in identifying people or gathering people for photographs. Beth Eggert Photography is not responsible if key individuals fail to appear or cooperate during photography sessions or for missed images due to details not revealed to Beth Eggert Photography.

SHOOTING TIME / ADDITIONS: The photography schedule and selected methodology are designed to accomplish the goals and wishes of the CLIENT in a manner enjoyed by all parties. The CLIENT and Beth Eggert Photography agree that cheerful cooperation and punctuality are therefore essential to that purpose. Shooting commences at the scheduled start time. For events that are 6 hours or more it is requested that a meal be provided for Beth and her assistant so that they will be able to remain onsite to continue coverage without interruption.

**HOUSE RULES:** The photographer is limited by the lighting and guidelines of the ceremony official or reception site management. The CLIENT agrees to accept the technical results of their imposition on the photographer. Negotiation with the officials for moderation of guidelines is the CLIENT's responsibility; Beth Eggert Photography will offer technical recommendations only.

FILM and COPYRIGHTS. Until final payment for services rendered is made, the photographs produced by Beth E ggert Photography are protected by Federal Copyright Law (all rights reserved) and may not be reproduced in any manner without Beth Eggert Photography's explicitly written permission. Upon final payment by the CLIENT, limited copyright ownership of the resulting images will be transferred to the CLIENT under the following conditions:

The negatives and or slides are the property of the CLIENT for personal use only and for the purposes of the reproduction and giving of photographs to friends and relatives.

The CLIE NT must obtain written permission from and compensate Beth Eggert Photography prior to the CLIE NT or its friends and relatives publishing or selling the photographs for profit.

**EXHIBITION:** Requests for specific negatives or slides to be used by Beth Eggert Photography may be requested at a future time. CLIENT grants Beth Eggert Photography permission to display selected images resulting from this assignment as an example of Beth Eggert Photography's work and for entrance into photographic competitions and release all claims to profits that may arise from use of images.

MODEL RELEASE: The CLIENT hereby grants to Beth Eggert Photography and its legal representatives and assigns, the irrevocable and unrestricted right to use and publish photographs of the CLIENT or in which the CLIENT may be included, for editorial, trade, advertising and any other purpose and in any manner and medium; to alter the same without restriction; and to copyright the same. The CLIENT hereby releases Beth Eggert Photography and its legal representatives and assigns from all claims and liability relating to said photographs.

LIMIT OF LIABILITY: In the unlikely event that the photographer is injured or becomes too ill to photograph the event, Beth Eggert Photography will make every effort to secure a replacement photographer. If the situation should occur and a suitable replacement is not found, responsibility and liability is limited to the return of all payments received for the event package. Beth Eggert Photography takes the utmost care with respect to exposure, transportation, and processing the photographs. However, in the unlikely event that photographs have been lost, stolen, or destroyed for reasons within or beyond Beth Eggert Photography's control, Beth Eggert Photography's liability is limited to the return of all payments received for the event package. The limit of liability for a partial loss of originals shall be a prorated amount of the exposures lost based on the percentage of total number of originals. While Beth Eggert Photography makes every possible effort to cap ture the event in its entirety, however in the unlikely event that a particular cap ture is missed, Beth Eggert Photography shall not be held liable.

SECURITY DEPOSITS: In the event of cancellation, the security deposit paid is non-refundable. It shall be liquidated damages to Beth Eggert Photography in the event of a breach of contract by the CLIENT. The CLIENT shall also be responsible for payment for any Beth Eggert Photography materials charges incurred up to time of cancellation.

Package time includes time from when Beth Eggert Photography begins photographing the wedding and until the moment that services are complete.

COMPLETION SCHEDULE: Digital processing and CD creation takes approximately two to three weeks after online viewing is available, although website photo availability usually occurs within one month for viewing online.

**PAYMENT SCHEDULE:** 25% due at time of signing of agreement. Balance payable in full two weeks prior to date of the wedding. If there are any time overage charges, photos will not be released to the CLIENT until the balance is paid in full. All packages are required to pay a 6% MI sales tax.
